



Due to a new Spanish legislation all airlines now require advance passenger information, details as follows:

RYANAIR

The Spanish Government has introduced new measures requiring airlines to provide, (before flight departure) the Passport or National ID data of all passengers onboard flights departing from the UK, Republic of Ireland, Poland, Slovakia, Malta and Morocco to Spain. This information is known as 'advance passenger information' ('API' or 'APIS' data)

When do the requirements come into force?

For all passengers traveling to Spain (including the Canaries and Balearic Islands) from the UK or Republic of Ireland from the 19th September 2007 onwards
 For all passengers traveling to Spain from Poland, Slovakia, Malta and Morocco from commencement of flights in October 2007.

What information will be sent?

Passport/National ID information, including:

- Passport/National ID information, including:
- Full Name (as they appear on the passport)
- Date of birth
- Nationality
- Passport or Travel document number
- Country of issue
- Type of Document (passport / ID Card)
- Expiry date of passport / I.D card

What if I refuse you permission to release my data to the authorities?

If you do not provide us with the required passenger information in you will not be accepted for travel at Check-In.

What will this information be used for?

The data may be given to Border Control authorities, who have a legal right to receive the data. They may share it with other enforcement bodies for the purposes of preventing and combating terrorism and other serious crime.
